Regulations and Conditions of this agreement:

Initials

1. _____ Pool party is not exclusive EFVCA members are welcome to use the pool.
2. _____ NO glass bottles of any kind are allowed on the premises.
3. _____ No water balloons. No floating objecting or large rafts or boogie boards in the pool.
4. _____ NO dogs allowed.
5. _____ EFVCA facility and grounds must be left clean and free of debris.
6. _____ All directional signs must be remove at the end of event.

7. _____ All trash must be bagged and removed from the premises. DO NOT use EFVCA Garbage Bins for disposal unless authorized to do so. Renter must provide own trash liners.
8. _____ All persons attending the scheduled function will do so at their own risk. EFVCA will not be held responsible for any lost articles, damaged property, or personal injury.
9. _____ Pool party cleanup must be completed no later than the end of the rental time.
10. _____ Set up time may vary and can be arranged at the time you book the event. Keep in mind, if there is an event scheduled that same day, your set up time may be scheduled closer to the time of your event.
11. _____ It is agreed by signing this agreement, any damage to EFVCA property or grounds will be the responsibility of the renter. If damages exceed deposit amount renter will be held responsible for balance due.
12. _____ I've received a copy of the pool rules and I understand it's my responsibility to ensure my guest abide by them. I also understand all children must be supervised at all times.

Security Deposit:

Intitals

1. _____ Deposit may be held for additional cleaning, damages to the facility, No Shows, or late Cancellations. Pool party security deposit maybe used to clear balance due at the discretion of EFVCA management.

Cancellation:

Please contact EFVCA immediately with any intention of cancellation. Entire security deposit will be forfeited if reservation is cancelled less than 30 days before function date.

Restrictions:

Any illegal activity (use of illegal drugs, gambling, etc.) as described in the Hawaii State Penal Code is strictly prohibited and will result in the termination of the function and the immediate notification of the Honolulu Police Department. All security deposits will thus be forfeited.

Pool Rules

1. NO LIFE GUARD ON DUTY- SWIM AT YOUR OWN RISK!
2. Children under the age of 14 MUST BE SUPERVISED BY AN ADULT AT ALLTIMES.
3. ALL users are required to take a shower before entering pool.
4. ALL users are required to wear appropriate swimwear. Long hair must be braided or tied back.
5. Children not potty trained must wear swim diapers.
6. No Food or drink is allowed in the pool.
7. Smoking is prohibited in the restrooms and all hall areas.
8. Pool users having an infectious or communicable disease/condition will be excluded from using the pool.
9. Pool users having open cuts, blisters or sores are warned that these are likely to become infected and are advised not to uses the pool.
10. Use of pool toys(inflatable rings, etc.) are subject to EFVCA discretion
11. NO DIVING
12. NO ROUGH PLAY
13. NO PUSHING OR SHOIVING
14. NO RUNNING
15. NO SPITTING, SPOUTING OF WATER, AND NOSE BLOWING IN THE POOL
16. NO FOUL OR ABUSIVE LANGUAGE
17. The pool shall be closed for cleaning in the event of an accidental fecal or vomitus discharge. All swimmers shall vacate the pool until pool is disinfected and water quality meets standards.
18. No pets allowed in pool.

Member and or guest failing to follow these rules or engaging in conduct deemed harmful to others users or management may be immediately removed from the pool.
